
# Parkwood Resident's Association

### Message from the President, Liz Brennan

The Planning Board has indicated that modifications need to be made to the plans for the new Kensington Safeway. There will be an informational meeting on the Safeway hosted by the Coalition of Kensington Communities on Thursday, May 29th at 7:30 pm at the Garret Park Town Hall. All interested Parkwood residents are encouraged to attend.

We are in need of a new volunteer to serve as the PRA representative on the NIH Community Liaison Council. The Council meets on the 3rd Thursday of every month at 4 pm. Current issues include the proposed bioterrorism facility - we need to be at the table on these discussions.

This is a call to action for volunteers. At this time it appears that we only have a few active committees Block Captain and Gardening. I believe there is a lot of interest in other committees but not enough leaders. I would very much like to revive the Traffic Committee and the Beltway Sound Barrier Committee. ## PRA to Host Speaker on Annual Growth Policy

The Annual Growth Policy (AGP) is undergoing a "top to bottom" review by Park and Planning and the County Council with the goal of ratifying changes in November of this year. Park and Planning has scheduled a series of forums to gather input from the communities on the AGP.

The AGP is the policy that is intended to be an instrument that facilitates and coordinates the use of various powers of government to limit or encourage growth and development in a manner that best enhances the general health, welfare and safety of county residents. County officials use the AGP to match the timing of private development with the availability of public facilities.

Based on the current gridlock on our roads and the overcrowded schools, it is probably safe to say that the current AGP is not working. As a friendly reminder to our elected officials at the County Council and the appointed officials at the Planning Board that we are an engaged and active community, I would like to have the Parkwood community weigh in on this issue. Karl Moritz, Research and Policy Planner for the Planning Board has been invited to our June 9th meeting to provide information on the current draft changes and how our community can participate in this important process.

### **Coalition of Kensington Communities (CKC)**

Community Center: Liz Brennan, Chair of the Community Center and Recreation Committee of the Coalition of Kensington Communities testified in front of the State House Appropriations Committee in Annapolis in March. Rich Madaleno, District 18 delegate, sponsored a \$100,000 bond bill for planning and design of a community center at the Housing Opportunities Commission site on Summit Ave. Given the grim financial picture at the state level, it's no surprise that the bill did not pass. Nevertheless, this opportunity was very good exposure for the cause. Committee members appeared to be very interested in the fact that a location and building have been identified and they asked questions and offered advice about going forward. We look forward to continuing work with our state and county representatives toward providing a community center for Kensington residents.

**Traffic:** The CKC testified in front of the Planning Board regarding Zoning Text Amendment (ZTA) 03-06 to eliminate the requirement for a traffic study at the zoning stage for a development. This ZTA was specifically created to help the LCOR development at White Flint (8 buildings: 20 stories high, 4 apartment buildings, 4 office building, plus retail space) through the zoning approval process. The argument given on behalf of the CKC is that more information is better than less and that requiring a traffic study at the zoning stage and another at the site plan stage would ensure enough time to allocate funding and allow community input. However, members of the Planning Board unanimously supported the ZTA and, by a 5 to 2 vote, County Council did the same. As a result, we have no idea at this time what the LCOR developers can do to effectively mitigate the traffic impact of their project.

**Development Impact Tax:** In May, Council members Tom Perez (District 5) and Phil Andrews (District 3) sponsored a bill to impose an impact tax on developers dedicated for

school construction. Montgomery County Schools are currently two years behind on a very conservative construction schedule (so conservative that elementary schools are being modernized once every 125 years!). Council member Perez authored a compelling editorial in the *Gazette* and support for this bill was broad- based and countywide. Some of the supporters included the Board of Education, Montgomery County Council of PTAs, the Town of Gaithersburg, the Town of Rockville, Montgomery County Taxpayers League, Montgomery County Education Association, NAACP, Solutions Not Sprawl, the Audubon Naturalist Society, and many more. CKC was pleased to testify and fully supports this effort. However, the proposal lost by a narrow margin in a contentious 5 to 4 vote. Those supporting the bill included Marilyn Praisner (District 4) and Michael Subin (at-large), as well as the sponsors. This set-back may be sorely felt by our community as funding for the KP modernization and the WJ modernization is at risk of being delayed even further.



There are 912 houses in the PRA membership area, yet only about 125 of them are represented in the association. Where are all of our neighbors? Surely they are interested in improving our safety, resolving traffic issues, understanding property taxes, learning about local development, and — most of all — meeting their neighbors.

Membership in PRA is an excellent way to stay informed about the things that affect us most directly and to lend your voice to an organization that represents us to the larger community.

# **Kensington Parkwood Elementary School: Registration Round-up**

According to the Montgomery County Public Schools' projections, Kensington Parkwood Elementary School is anticipating an additional 30 students in grades 1 through 5 next school year. The projected 2003-04 kindergarten enrollment is 70. Currently, fewer than 50 kindergarten students have enrolled for the fall.
