Renew Montgomery Coming to Parkwood

Parkwood has been selected for the County's FY2005 Renew Montgomery Program to repair deteriorated sidewalks, curbs and gutters as well as to make other infrastructure refurbishments. While in our neighborhood, the Department of Public Works and Transportation (DPWT) can coordinate other appropriate activities including:

- Sidewalk, curb and gutter repair
- Roadways base repairs and resurfacing
- ADA improvements
- Traffic calming • Street lighting
- Sign and marking maintenance
- Bus stop amenities
- Tree maintenance and neighborhood beautification
- Storm drain improvements

We can use this opportunity presented by the county to address issues that have been mentioned by many residents over the past several years. This is our chance to advocate and coordinate for neighborhood enhancements. We're looking for feedback from the residents as to what and where they feel improvements should be made AND volunteers to shepherd this effort. This will be an agenda item for the June meeting.

WSSC Water Main Update

Those of you who attended our March members' meeting heard a report from Bill Zwack and Tom Robertson, our PRA representatives on the WSSC Community Advisory Committee, on WSSC's proposed plans to construct a large water main from Tuckerman Lane to Beach Drive near the Mormon Temple. WSSC has essentially narrowed its choices of possible "alignments" (for running a 7-foor diameter water supply pipe 150 to 300 feet below ground) to the following three tunneling scenarios: 1) under Saul Road, 2) under Rock Creek Park and/or Beach Drive (along the Beltway), or 3) under Beach Drive north of the 355 access road to under Knowles Avenue. In other words, the alignment involving the defacing of Rock Creek Park above ground is virtually off the table. For a tunneling alignment, three vertical shafts will be drilled...one at each end and one in the middle, possibly removing one acre of trees in Rock Creek Park near the 355 access to Beach Drive. Also, geophysical testing (surface probes and soil sample boring) will occur on and off starting in May along the three tunneling alignments.

As tunneling 150 to 300 feet below either Saul Road, Rock Creek/Beach Drive, or Beach Drive/Knowles Avenue are the likely scenarios for the new 7-foot-diameter water supply pipeline by WSSC, you may notice crews in and around the neighborhood for another week or two performing geophysical testing. This testing is minimally disruptive and involves laying wires for 1,000 feet in a straight line, with probes into the ground every 20 feet or so. There will not be loud noises, excavation, or traffic disruption. As it is a concern of many residents, it appears that at this time the WSSC scenarios to "cut and cover" a pipe through Rock Creek Park (15 feet below the surface) is virtually off the table. However, the deeper tunneling scenarios mentioned above will likely require a 1-acre clearing of trees in the park for a vertical shaft.

KP_Elementary_School_Modernization_Landscaping

At the March meeting the landscaping plans for KPES were displayed for community perusal and discussed briefly. PRA representatives Bill Zwack and Liz Brennan met with Parks and Planning (P&P) after concerns had been raised about a variety of issues including proposed trees on the sledding hill and border foliage. MCPS agreed to relocate (on-site) the approximately 17 trees that were planned for the sledding hill. They also agreed to revisit the plans for screening the building from the bordering residences. Additionally MCPS agreed to address ground cover concerns if it turns out that grass is unable to grow due to the amount of trees to be planted. A copy of the landscape design will be available again at the June PRA meeting.

Parkwood and the Beltway

PRA has been active over the years, working with other neighborhood associations to oppose adding additional lanes to that part of the Beltway (495) that runs adjacent to the neighborhood and through Rock Creek Park In particular, Parkwood has been a founding and active member of the Rock Creek Coalition which includes neighborhoods along both sides of the beltway from Rockville Pike over to Colesville, and worked cooperatively with the Action Committee for Transit whose focus is on adding light rail (trolley) cars instead of adding more lanes for cross-county traffic.

Originally, putting the beltway through the park was controversial, and promises were made to limit the size. Subsequently those promises were forgotten and additional lanes added. Parkwood and other neighborhoods along this stretch of the beltway have opposed further expansion – to limit noise, pollution, and impact on the park. Nevertheless, the Maryland Highway Administration continues to be interested in adding lanes to both 495 and 270. Virginia has recently decided to go ahead and do so south of the bridge. Various residents have taken the lead on this issue over time and we're looking for fresh blood. Please help your neighborhood and give Liz Brennan a call to volunteer!
