BELTWAY WIDENING UPDATE

After several meetings the PRA along with the Rock Creek Collation have proposed a declaration of principles in response to the State Highway Administration's (SHA) soliciting a range of views in response to the proposed solutions to traffic congestion on I-495 and nearby roads. The following excerpts are taken from that statement:

The Coalition insists that our elected representatives take a proactive stance. We expect that they will act to preserve the beauty of Rock Creek Park. We are not prepared to accept physical encroachment on parkland.

We agree that traffic already exceeds capacity on I-495 and that traffic will continue to grow. Previous promises from state, federal and EPA officials to limit traffic, noise and air pollution have not been kept in a timely manner.

That Rock Creek Park is invaluable as flood plain. If the additional lanes are built, instead of flood plain protecting adjacent areas from flash floods, we will have concrete roadway shedding water and snow, greatly exacerbating an acute situation.

Expansion of I-495 would involve the destruction of valuable parkland, already in short supply. This section of Rock Creek Park is one of the most beautiful small parks along the Eastern Seaboard.

Our Coalition strongly recommends that SHA immediately implement a feasibility study of bus transit around the Beltway, using existing lanes with rush-hour priorities. State and local governments should help fund mass transit services at a level commensurate to the savings in capital improvements (expansion of I-495) which would no longer be necessary.

Members of the Rock Creek Coalition agree to keep members of their individual citizens associations informed of the stands taken on these issues by our elected representatives.

TRAFFIC COMMITTE UPDATE

Parkwood Drive Petition Fails

At the last meeting of the PRA Traffic Committee in July, a consensus was reached supporting raised crosswalks along Parkwood Drive at Park entrances (Saul Rd & Westbrook Ln). Park entrances are located at the base of various hills along Parkwood Drive, and coincide with dangerous traffic speeds.

Since then the PRA has contacted the Montgomery County Traffic Engineering Division many times for evaluation on the proposed crosswalks and the PRA has followed up these efforts in writing. The letter has been forwarded to the Maryland National Park and Planning Commission and the PRA is waiting for response.

During this time, some residents pursued the circulation of a petition for the installment of speed humps along Parkwood Dr. between Westbrook Ln. and Franklin St. The petition process requires that each household along the roadway vote either for, or against, the speed humps. Preliminary results of the petition indicated that more than 25 percent of the total households were against the initiative, making passage of the petition impossible.

Perhaps Parkwood is approaching some form of balance in their pursuit of a safe and beautiful community in which we can live together. The pickup came up the driveway about 4:15pm. I wasn't expecting anyone. The driver was from Maryland Geographic, here to photograph bridges in the Parkwood area and looking for directions. I accepted his invitation to go along, so I can tell you when we'll be able to use those bridges again.

We began at the new Summit Avenue bridge over the train tracks in Kensington. It's almost finished, and may be open to traffic as soon as July this year. Next, we drive by the new bridge where Saul Road crosses water at Kensington Parkway. It's just completed stonework has made the wait almost worthwhile, and the span may be open by the time you read this.
