BELTWAY UPDATE

As a result of the activities of the Rock Creek Coalitionmore than 15 community associations brought together at the suggestion of our own Robert Lodge-the schedule for completion of the current study phase of the project has been pushed back into next winter. While the State did not agree to our request for a 6 month moratorium, the slowdown provides essentially the same opportunity - to increase citizen awareness and involvement, to more thoroughly map out where mass transit lines might run, and to get a better fix on what land might have to be taken if extra lanes were added to the beltway. In a recent meeting, the representatives of the State also conceded several points previously made by the coalition - that Maryland's solutions to its beltway congestion problems do not necessarily have to be the same as Virginia's, and that the solutions for congestion in an east-west direction do not necessarily have to be the same as the solutions for congestion on the portions of the beltway which are part of major north-south corridors.

The Rock Creek Coalition has requested that at each member community's next meeting, the community decide whether the Coalition should take any of the following specific positions AT THE POINT IN TIME. Please give them some thought to these before the Parkwood meeting.

- 1) Oppose the addition of any lanes of any type to the beltway (i.e., on the stretch between Rockville Pk and I-95).
- 2) Support a no-build approach (i.e., let congestion have its natural effects).
- 3) Support a mass transit solution to congestion.
- 4) Support a pilot project on the value of HOV running east and west in which existing lanes would be converted to HOV use.
- 5) Support legislative initiatives to alleviate traffic demand- e.g., financial incentives for public transportation, parking fees for single-occupancy vehicles (e.g., NIH)
- 6) Support legislative initiatives to promote safety e.g., electronic monitoring and traffic enforcement.
- 7) Support, during this year's reauthorization of major Federal transportation legislation, Federal funds for a well run regional transportation planning initiative.
